

By-Law No. 789 of the Municipal District of Starland No. 47

A by-law for the purpose of entering into an agreement with various other municipalities to provide for the operation of a regional library system.

WHEREAS; pursuant to Sections 118 and 210 of the Municipal Government Act which provides that a Council may by by-law enter into an agreement with other municipalities for the joint operation of a regional library system; and

WHEREAS; the term of the agreement is for three years from January 1st, 1981 to December 31st, 1983 with the annual requisitions being fixed as per agreement; and
