CAO Report

Chief Administrative Officer Shirley Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- CAO Bremer and Public Works Supervisor Menage met with Derek Beattie of Stantec to discuss the upcoming tender for the construction of the Lenfesty Bridge, BF.06918. The Stantec bridge team did review the information supplied by Council regarding the ACROW bridges which had declared significant cost savings from more traditional bridge structures. The bridge team determined that the type of structure that was proposed would not be adequate for rural use (to accommodate heavier axle loads for farm equipment and loaded farm trucks or wider loads) and recommended that the original bridge design be utilized. Stantec hopes to get the proposal out early in 2023 and get a tender approved for construction in mid-2023 and completed no later than October 31st.
- In discussions with MPE Engineering, the County has noted the urgency to try and obtain additional water allocation from the Red Deer River as soon as possible. This will require doing an inventory of what we already have and what we are utilizing. Then preparation

of proposals for the various projects to determine the approximate amount of water required for each. Potential water projects include expanding the Kirkpatrick waterline to supply water past the campground to existing residences as well as new developments near the golf course; update the proposal for supplying water to Rowley and Rumsey from the Morrin West line; and a proposal to supply Michichi from either the Henry Kroeger Regional Water Commission or from Drumheller. MPE will work on these proposals and then we should be prepared to apply for water study funding through the ACP grant, and then hopefully funding will be available for pipeline construction at some point in the near future.

- The Starland County Christmas party was a huge success with everyone attending have a good time.
- CAO Bremer reported that the road closure for Bob Grenville has now finally been approved. The road closure will still have to be registered and the County will have to invoice Bob for the sale of land.
- CAO Bremer congratulated Council in appointing a new CAO for Starland County and wished the County all the best in the future.

Draft 2023
Interim Budget

Corporate Services Director Fazekas presented the 2023 draft interim operating budget. Highlights of the interim operating budget are:

- There has been a budgeted 2% overall increase to taxation revenue. This increase was necessary to offset decreases in other operating revenues.
- Projected operating revenue is \$15,372,346 and operating expenses are \$15,342,855 for a projected operating surplus of \$29,491.
- Projected capital finances acquired is \$3,051,812 and projected capital finances applied is \$3,048,000 for a projected surplus of \$3,812.

Council is required to approve an interim budget before January 1st so operations can continue; however, the final budget will not be approved until later in 2023.

Tax Write Offs

MPE Engineering has submitted proposals for undertaking three feasibility studies for possible regional water projects in Starland County. The projects and estimated costs for these studies are as follows:

1. Extending treated water supply from the existing Kirkpatrick/Prestige RV Campground waterline for possible water service to potential commercial and residential developments in the Red Deer River Valley. Estimated cost for study - \$19,900.00.
2. Extending treated water supply from the existing Morrin West Rural Water System north to the Hamlets of Rowley and Rumsey. Estimated cost for study - \$18,200.00.
3. Providing treated water supply to the Hamlet of Michichi, either from the existing Morrin Rural Water system or from the existing Craigmyle Rural Water system, or possibly from both sides. Estimated cost for study - \$23,200.00.

Council also requested that MPE explore the possibility of partnering with Stettler County and the Village of Big Valley to see if treated water can be supplied to Rowley and Rumsey from the Shirley McLellan Regional Water system.


