Attendance of Acting PWS Pratt & PW Report

At 9:35 a.m., Acting Public Works Supervisor Pratt attended the meeting and reviewed his Public Works Report with Council. Highlights of his report included the following:

- They started hauling screened rocks from the Courtney Pit to stockpile at Ducks Unlimited for the rock chute;
- Pumped water in Rumsey for the third time this year. They are now checking for a water leak;
- Crews have been installing signs & culverts;
- Several employees have completed their First Aid Courses now;
- Brenda's new patrol unit is now ready. Her old unit will be utilized by Diana Rowe; and
- The Road Crew has commenced work on the Princeton Road Project.

Mixcor Aggregates re: Gravel Supply Proposal

Mixcor Aggregates proposed an exchange of materials that they currently have available at their Zipper Pit. The original agreement was to provide 150,000 cubic yards of D 4 CI 20 gravel. However, they are only able to provide 125,000 cubic yards of this material at this time. In place of the

25,000 yards that they are short, they are proposing to offer 29,845 cubic yards of 20mm Road Crush (2-20 material), netting the County 4,845 cubic yards of material for no additional cash outlay. The total amount payable to Mixcor would be the same as the amount of the original contract.

CAO Report

Chief Administrative Officer Ross Rawlusyk reviewed his CAO Report with Council. Highlights of his report included the following:

- He has spent a considerable amount of time compiling the final version of the 2012 Budget, noting that the budget implementation of TCA accounts certainly impacts capital budgeting and long term planning;
- He is still working on project deficiencies related to the Administration Office. A major review is scheduled with the Architect on June 14th, 2012;
- Alberta Environment just released a new version of the Code of Practice for Waterworks Systems Using High Quality Groundwater, which becomes effective June 1st, 2012;
- He recently attended the Municipal Administration Leadership Workshop in Kananaskis;
- The Annual Employee Family Picnic is tentatively scheduled for Friday, July 27th, 2012 in Rowley; and
- Most of the senior supervisors completed safety training in Incident Investigation Formal Workplace Inspections and Hazard Identification, Assessment and Control.

2012 Annual
Operating &
Capital Budgets

CAO Rawlusyk reviewed in depth the proposed 2012 Annual Municipal Operating and Capital Budgets for Starland County with Council. The major projects for the year 2012 were highlighted and noted that the total operating budget expenditures are estimated at \$14,070,687.00 and the total capital budget is \$3,494,805.00 with an overall budgeted surplus of \$120,548.00. Within this budget there will be a slight increase of 2% to the municipal mill rate for all properties. However, CAO Rawlusyk noted that the assessments of most rural residences decreased approximately 15% which will likely offset any total taxation increase on these properties. The School tax rates increased 7.56% for Residential and Farmland properties, and decreased 4.35% for Non-Residential properties. The Non-Collection Allowance increased 11.53% and the Drumheller and District Senior's Foundation mill rate increased 19.23%.

Municipal Services
Report

CAO Rawlusyk reviewed Manager Riep's Municipal Services Report. Highlights of his report included the following:

- The crew has been busy with the initial start-up of the campgrounds and general maintenance operations getting them ready for the long weekend and upcoming summer season;
- He has prioritized the maintenance operations schedule to ensure that things are dealt with appropriately. Cemeteries receive priority when there is an interment to ensure the grounds are well kept during these events. Recreation grounds require frequent attention and are dealt with weekly and as required. Public properties in the hamlets such as playgrounds, ball diamonds, roadway boulevards are next on the list and are attended to at a 2 - 3 week turn around during the growing season depending on the weather and other factors. Municipal properties are done less frequently and as needed while private work is done only on a time permitting schedule. Special events are worked into the schedule to ensure those events areas are made presentable;
- The Michichi wash house controls that were vandalized have been repaired;
- Various water repairs have been completed, with others ongoing;
- Large boulders have been placed strategically at various locations in the recreation sites to provide barrier protection;
- He met with a representative of the Alberta Government Solicitor General Office to discuss the development and implementation of the Alberta First Responders Radio Communications provincial radio system. They are hoping to gain support from the municipalities in the form of a "process commitment" towards the development of the service in our area and may eventually be asked to commit to tie into this system. He recommended that a complete review by a qualified communications firm would help the County to determine which direction we need to proceed before investing a lot of capital.

FCM Resolutions & Information

CAO Rawlusyk provided Council with the 2012 Resolutions that will be discussed at the upcoming FCM Conference in Saskatoon, Saskatchewan from June 1st to 4th, 2012. In addition, they received their accommodation confirmations and convention programs.

CN re: Rail line Acquisition

Correspondence was received from John Brayley, Manager of Network Strategies with CN. He reviewed the benchmark dates and issues that have occurred, outlining where things are at to date. He also reviewed CN's offer to the municipalities to transfer the rail assets (including rail, ties, ballast, bridges, crossing protections systems and other track materials) for Twelve Million Dollars, noting that the current offer terminates on July 15th, 2012 with a closing date of October 15th, 2012. If the offer is not accepted by then, the transfer price will increase. CN is looking forward to hearing back from the municipalities on this issue and would be willing to meet with them in Drumheller in early June.

Resignation of Assessor, Barry Kautz

CAO Rawlusyk advised that Starland County's Assessor, Barry Kautz, of Regional Assessment Management Services has provided notification of his retirement, effective May 31st, 2012. Barry also suggested that Wild Rose Assessment Services Inc. out of Red Deer might be interested in providing assessment services to Starland County, as they are already doing several municipalities within this area.

Wild Rose Assessment Services RFP for Provision of Assessment Services

In this respect, Wild Rose Assessment Services submitted a proposal for the delivery of assessment services, based on a five (5) year term from June 1st, 2012 to May 31, 2017. They noted that if the County entered into an agreement with their firm, they would be sub-contracting out the Industrial Assessment to Independent Municipal Assessment Corporation (IMAC) as was previously done. A schedule of their proposed contract costs was also included for this five year term.

Alberta First Responders Radio System re: Process Commitment Document

CAO Rawlusyk discussed information in regards to the Alberta First Responder Radio Communications System (AFRRCS). Council reviewed the *Process Commitment Document* which in non-binding but shows a commitment on behalf of each agency that signs it to explore the Alberta First Responders Radio System as a solution to the public safety radio requirements.

Proposed Municipal Heritage Resource Bylaw for Craigmyle United Church

CAO Rawlusk reviewed his report with regards to a proposed new bylaw, which would authorize Starland County to designate the Craigmyle United Church as a Municipal Heritage Resource pursuant to Section 26 of the Historical Resources Act. First reading was previously given to Bylaw 1095 to designate both the Craigmyle United Church and the Springwater School. The issues with the transfer of the Springwater School has held up the Craigmyle Church designation. He recommended to proceed with the first reading of Bylaw No. 1111 to designate the Craigmyle United Church as a Municipal Heritage Resource pursuant to the Historical Resources Act. Once this is complete, the County must provide written notification to the Craigmyle United Church relative to this designation. Once the notification period is complete, this bylaw can receive second and third readings and be registered at Land Titles. He also suggested that in the longer term, Council may want to consider forming a committee to work on Historical Resource funding locally.


