### CAO Report

Chief Administrative Officer Shirley Bremer reviewed the CAO Report with Council. Highlights of the report included the following:

- Ryan Hallett has accepted the offer for the position of Ag Fieldman and will commence work on Monday, April 19, 2021. He comes to us from the County of Stettler where he has worked for the past 6 years as Manager of Agricultural Operations.
- The updated assessment for the 2021 levy has resulted in an overall decrease in assessment from 2020 by 2.8% for a total value of \$649,284,230. However, this represents a 21.8% decrease from our one-time high assessment in 2015 of \$830,225,930.
- The 2020 Financial Audit was completed on April 6, 2021. Due to tight fiscal restraints in 2020 and better than forecasted tax collection, the County recognized a surplus at the end of the year sufficient to replenish the reserves that were depleted in 2018 and 2019.
- CAO Bremer and Public Works Supervisor Menage met with WSP regarding the remediation of the contaminated land south of the parking lot. Only two of the test bores showed high levels of contamination, however they were very deep at a level of at least 9 meters. There are two options: one would be to clean up the site and remove all the contaminated soil at an estimated cost of \$300,000.00; or prepare a Risk Management Plan (RMP) which

would have to be accepted by Alberta Environment and would likely require further action in the future such as additional sampling and monitoring. WSP will prepare the RMP and send it to us for review prior to submitting to AE. AE will decide whether this plan will be accepted and what else may be required by us in this regard.

- Administration has been working closely with Tim Duhamel from BLOOM to fine-tune our Strategic Plan document. He will now be contacting Council to get their "Message from Council" so that the Strategic Plan document can be completed.
- The Tolman Bridge lease agreement is now signed, and Administration is planning to meet with the Provincial reps to do a walk-through of the site and discuss any outstanding issues.
- Assistant CAO Kreke's last day of work will be April 15, 2021. CAO Bremer thanked Matthew for his dedicated service over the years and wished him the best of luck in his future endeavours.
- CAO Bremer provided an update on the installation of a bottom load at the Craigmyle Truck Fill. Municipal Services Director Riep has ordered the parts to properly install the bottom load to ensure no possibility of water contamination. He expects that the new bottom-load feature at the Craigmyle Truck Fill will be operational by early May.

Administration has recently met with the Morrin Historical Park and Sod House Society and has received a written proposal asking for assistance from the County in establishing a campground within the Village of Morrin on the County's railway right-of-way property. The Society is asking that Starland County apply for the development permit from the Village of Morrin, and supply the garbage bin, registration box, gravel, fire pits and picnic tables for 10 – 12 sites. The Society would be responsible for the operation of the campsite and would receive a portion of the revenues.

Councillor Rew proposed that paragraph 9(1)(b)(ii) be revised to read “a twin steer with non-mounted equipment exceeds 13,600 kilograms or a twin steer with mounted equipment exceeds 15,200 kilograms.”

Directive 67

The Alberta Energy Regulator (AER) has released revised *Directive 067 Eligibility Requirements for Acquiring and Holding Energy Licences and Approvals*. Changes to the Directive include additional requirements to provide updated financial information at the time of application and throughout the energy development life cycle, including unpaid municipal taxes and surface lease payments. Alberta municipalities can also share their concerns with the AER regarding unpaid municipal taxes by submitting a statement of concern on Directive 067 applications which are posted on the AER website. Starland County will have to determine how this will work going forward and how we will monitor and report our concerns to the AER.

Road Program  
Meeting

The annual Road Program Meeting has been rescheduled for April 20, 2021 at 1:00 p.m. The road gravelling program will have to be finalized at that time and to what extent a dust control program will be implemented so that this cost can be included in the final budget. Public Works will prepare dust control estimates to address priority areas.

A road tour will tentatively be planned for later in the year using a larger bus.

Purchase of New Photocopier

The Public Works photocopier is requiring replacement as it is approximately 12 years old, and parts are no longer available for repairs. Digital Connections has extended a sale on their Ricoh copiers to the end of April 2021. We have received two quotes: Ricoh IM C6000 (60 ppm) for \$11,680 and the Ricoh IM C8000 (80 ppm) for \$17,869. Both models have 4 trays, booklet finisher, duplex, auto toner order, and installation/delivery included. The service rates are competitive with rates we are currently paying on the Canon copiers.

Tax Incentive Agreement with Subra Limited Partnership

The tax incentive agreement between Starland County and Subra Limited Partnership has been finalized for the Fox Coulee Solar Project development. The agreement allows for a fifteen (15) year deferral on property taxes commencing on the Property Tax Payment Date in 2021 and remains in effect until the Property Tax Payment Date in 2036. The extent of the Deferral for the Qualifying Property is fifty (50%) percent of the assessed value of the Qualifying Property for 2021 – 2031 (ten years), and the repayment of the accrued deferred property taxes in 2032 – 2036 (five years).

Aura Power had agreed to pay for the legal costs of drafting the agreement up to an amount of \$15,000.00. However, the actual legal costs to date are more than \$36,000.00. Matthew has contacted Aura Power to see if they would consider paying a portion of the additional legal costs.
